


Terms and conditions

1. **NAME OF WORK- PROVIDING AND FIXING PREFABRICATED BOUNDARY WALL IN ONE CORNER OF Government Polytechnic Education Society MANESAR, VPO Manesar(Gurugram)**
2. **BID SECURITY** – The bidder shall furnish bid security in the amount not less than 2% of the bid Amount.
3. **SCOPE OF WORK** - The scope of work for a precast RCC boundary wall includes:
 - **Site preparation:** Excavating and compacting the site
 - **Transportation and lifting:** Using cranes to move precast concrete wall panels into place
 - **Alignment and stability:** Ensuring the pieces are properly aligned and stable
 - **Grouting:** Grouting the pieces together and backfilling.
 - **Safety:** Using proper rigging equipment, following load limits, and wearing protective gear.
 - **Duration :** The work should be completed within 3 weeks after allotment date.
4. The bid security is required to protect the Principal, GPES Manesar against the risk of bidder's conduct which would warrant the security forfeiter. The bid security shall be deposited in the form of demand draft payable in the favour of Principal GPES Manesar. The bid security i.e.2.0% of Tender Estimated cost deposited by the successful bidder will have to be converted into performance Security deposit
5. Any bid not accompanied by acceptable bid security will be rejected by Principal GPES Manesar
6. The bid security may be forfeited if a bidder withdraws his bid during the period of validity specified by the bidder on the bid forms.
7. Late bids- Any bid received by Principal GPES MANESAR after THE DEADLINE for SUBMISSION OF BIDS prescribed by Principal GPES Manesar will be rejected and returned unopened to the bidder.
8. A committee constituted by Principal GPES Manesar will open the bids in the office of institute and Evaluate.
9. Principal GPES Manesar will award the contract to the bidder whose bid has been determined to be substantially responsive to the bidding document and who has offered the lowest bidding price and the bidder must be listed with PWD, HARYANA
10. **PERFORMANCE SECURITY-** After letter of acceptance from Principal the successful bidder shall furnish to Principal GPES Manesar a performance security for an amount of 5% of contract price in the form of demand draft payable in the favour of Principal GPES Manesar. Performance bank guarantee shall be valid until a date 15 days after the expiry of Defect Liability-cumMaintenance Period.
11. The maintenance period after completion of work will be six months. The bidder is required to quote his rate for routine maintenance.
12. The decision of Principal GPES Manesar will be final in case of any dispute.
13. Last date of receiving sealed tender in this institute is **04 December 2024 by 4:00pm.**
14. The full payment will be made ON ACTUAL MEASUREMENT BASIS AND within 15 days after satisfactory completion of work.

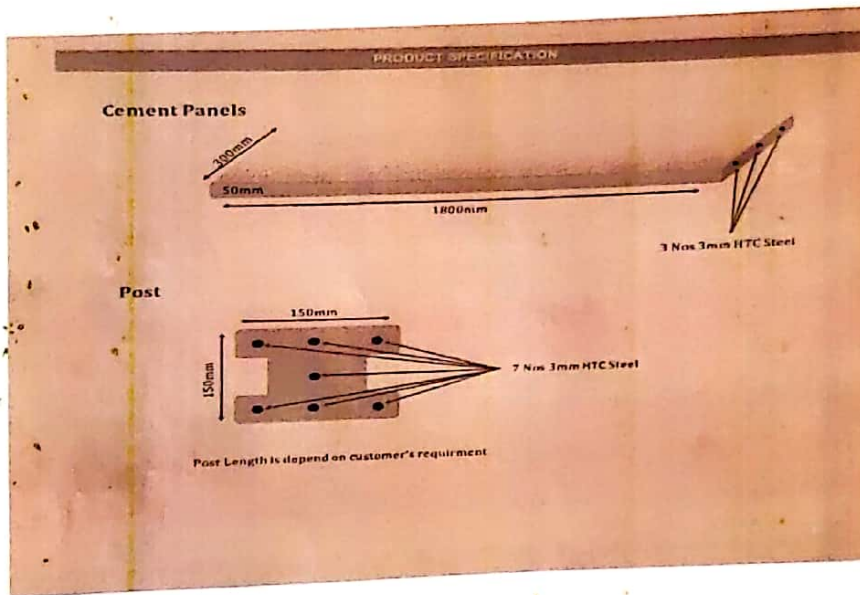

PRODUCT AND DESCRIPTION

1. 5 to 10 feet available Feet High Precast Boundary Wall Panels of size 1800mm X 300mm X 50mm Reinforced high tensile with 3 Nos. longitudinal bars of 3mm.
2. Post : 150 x 150 mm Thick (are Reinforced high tensile with 7 Nos.)
3. Height of the pillar shall be 600mm extra on height.
4. Post must be provided with 60 cm foundation in cement concrete (1 : 4 : 8)
